Topic 1 – Abstract submission - Deutsche Gesellschaft für Biomechanik in Köln (28.09 – 01.10)

- AML recommends to represent EmpkinS at this national conference
- Discussion about availability and content for an abstract:
- submission deadline 2nd May: time conflict for BC and SH because of GAPX data collection (March – May 2022)
- Biannual conference → we will attend in 2024 with hand data
- AML might submit EmpkinS Pilot data or gait data – TBD until April 20th
- Other EmpkinS Members with biomechanical subprojects will be contacted and informed about the deadline

tasks and responsibilities:

- AML checks for a suitable topic for an abstract submission
- AML will contact other groups to see if they attend the meeting
- BC and SH will inform other doctoral candidates about the conference and deadline

topic 2 – status update

- GAP X data collection started at the end of March 2022, subject recruitment is ongoing, data collection is performed at LTD and UKER Med3, 16 healthy control participants have completed data collection, hand vigerometer measurements could not be performed because of delivery issues – device should arrive around April 11th.
- BC and SH abstracts are accepted as oral presetations at the 9th World Congress of Biomechanics WCB from the 10th to 14th July 2022 at the Taipei International Convention Center (TICC) in Taipei, Taiwan. Both will attend in the virtual congress.
- BC abstract is accepted as Poster view at the Annual European Congress of Rheumatology EULAR 2022 Copenhagen, Denmark – 1-4 June 2022.
- BC abstract is accepted as Poster presenatation at the 27th Congress of the European Society of Biomechanics ESB 2022, Porto, Portugal - 26 – 29 June 2022.
- BC and SH will attend ESB 2022 in Porto in person, they will book hotel rooms and flights as soon as possible, SL and AML recommend to attend conference dinner for networking (get to know scientists from the same research area)

tasks and responsibilities:

BC and SH: book trip to Porto, DR Anträge, prepare talks as posters

topic 3 – supervision agreement
